The provisions of the State Services Conditions of Employment Amendment Act 1987, so far as they relate to the New Zealand Railways Corporation, shall come into force on the 10th day of November 1987.

Explanatory Note

This note is not part of the order but is intended to indicate its general effect.

This order provides that the provisions of the State Services Conditions of Employment Amendment Act 1987, so far as they relate to the New Zealand Railways Corporation, shall come into force on 10 November 1987. That Act was amended by the State Services Conditions of Employment Amendment Act (No 3) 1987.

By virtue of this order the New Zealand Railways Corporation will be placed, on 10 November 1987, on the same basis as other State enterprises in relation to the determination of the conditions of employment of its employees. Part 8A of the State Services Conditions of Employment Act 1977 (which relates to State enterprises and which was inserted by section 11(1) of the State Services Conditions of Employment Act (No 3) 1987) will thus apply in respect of the New Zealand Railways Corporation.
