Order

1 Title

This order is the Social Security (Rates of Benefits and Allowances) (COVID-19 Recovery Package) Amendment Order 2020.

2 Commencement

This order comes into force on 27 March 2020.

Order: confirmed, on 12 December 2020, by section 13(b) of the Subordinate Legislation Confirmation Act 2020 (2020 No 66).

3 Principal order

This order amends the Social Security (Rates of Benefits and Allowances) Order 2020 (the **principal order**).

4 Clause 2 amended (Commencement)

In clause 2(2)(d), replace “4” with “3, 4,”.

5 Clause 6 amended (Discretionary increases under section 452 of Social Security Act 2018)

After clause 6(2), insert:

- (3) In each provision of the Social Security Act 2018 listed in the first column of Part 3 of Schedule 2 of this order, replace the amount set out opposite to that provision in the second column with the amount set out opposite to that provision in the third column.
- (4) In each provision of the Social Security Act 2018 listed in the first column of Part 4 of Schedule 2 of this order, replace the amount set out opposite to that provision in the second column with the amount set out opposite to that provision in the third column.

6 Schedule 1 amended

In Schedule 1, Part 1, item relating to Schedule 4, Part 3, after the item relating to clause 1(h)(ii), insert:

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 27 March 2020, amends the Social Security (Rates of Benefits and Allowances) Order 2020 (the **principal order**) made under the Social Security Act 2018 (the **Act**). Adjustments or increases made by the principal order (including those adjustments or increases as amended by this order) come into force at, or immediately after, the start of 1 April 2020.

Mandatory adjustment: rate of supported living payment

Clauses 6 and 7(2) relocate, in the principal order, the item relating to the increase in the rate of supported living payment set out in clause 2 of Part 3 of Schedule 4 of the Act. To correct a misdescription of the increase, this item is relocated, in the principal order, from Part 1 of Schedule 2 (discretionary increases) to Part 1 of Schedule 1 (mandatory adjustments).

Discretionary increases: income limits for youth payment and young parent payment

Clause 7(3) makes discretionary increases, inadvertently omitted from Part 1 of Schedule 2 of the principal order, to income limits for youth payment and young parent payment. These increases are informed by the increase of 1.66% in the New Zealand Consumers Price Index from the December 2018 quarter to the December 2019 quarter.

Discretionary increases: COVID-19 Recovery Package increases to social security benefits

Clauses 5 and 7(4) insert in the principal order *new clause 6(3)* and *new Part 3* of Schedule 2. To address economic impacts of COVID-19, that *new Part 3* makes discretionary increases to rates of the following benefits:

- jobseeker support:
- sole parent support:
- supported living payment:
- youth payment and young parent payment:
- former widows' benefit:
- former domestic purposes benefit.

Discretionary increases: COVID-19 Recovery Package increases to winter energy payment

Clauses 5 and 7(4) also insert in the principal order *new clause 6(4)* and *new Part 4* of Schedule 2. To address economic impacts of COVID-19, that *new Part 4* makes discretionary increases to rates of winter energy payment. These increases will apply for the 22-week winter period starting on 1 May 2020.

Order is confirmable instrument and annual confirmable instrument

This order is a confirmable instrument, and an annual confirmable instrument, under section 47B of the Legislation Act 2012. It is revoked, or taken to have been invalid for past operation, at the close of 30 June 2021 unless earlier confirmed by an Act of Parliament. That stated time is the applicable deadline under section 47C(1)(a) of the Legislation Act 2012.
