Order

1 Title

This order is the Social Security (Rates of Benefits and Allowances) Order 2013.

2 Commencement

- (1) This order comes into force on 1 April 2013.
- (2) By way of explanation,—
 - (a) clause 4 comes into force on 1 April 2013 by virtue of section 61HA(5) of the Social Security Act 1964:
 - (b) clause 5 comes into force on 1 April 2013 by virtue of sections 15 and 16 of the New Zealand Superannuation and Retirement Income Act 2001:
 - (c) clause 6 comes into force immediately after clauses 4 and 5 come into force.

Order: validated and confirmed, on 18 December 2013, by section 13(b) of the Subordinate Legislation (Confirmation and Validation) Act 2013 (2013 No 142).

3 Increasing amounts of funeral grants

- (1) In the Social Security Act 1964, sections 61DB, 61DC, and 61DD, replace “\$1,959.42” with “\$1,971.37”.
- (2) The amendments made by subclause (1) apply in respect of persons who die on or after 1 April 2013.

4 Mandatory adjustments under section 61HA of Social Security Act 1964

In each provision of the Social Security Act 1964 listed in the first column of Part 1 of Schedule 1, replace the amount set out opposite to that provision in the second column with the amount set out opposite to that provision in the third column.

5 Mandatory adjustments under sections 15 and 16 of New Zealand Superannuation and Retirement Income Act 2001

In each provision of the New Zealand Superannuation and Retirement Income Act 2001 listed in the first column of Part 2 of Schedule 1, replace the amount set out opposite to that provision in the second column with the amount set out opposite to that provision in the third column.

6 Discretionary adjustments under section 61H of Social Security Act 1964

- (1) In each provision of the Social Security Act 1964 listed in the first column of Part 1 of Schedule 2, replace the amount set out opposite to that provision in the second column with the amount set out opposite to that provision in the third column.
- (2) In each provision of the New Zealand Superannuation and Retirement Income Act 2001 listed in the first column of Part 2 of Schedule 2, replace the amount set out opposite to that provision in the second column with the amount set out opposite to that provision in the third column.
- (3) The amendments made by this clause take effect from the close of 31 March 2013.

7 Revocations

- (1) The Social Security (Rates of Benefits and Allowances) Order 2012 (SR 2012/21) is revoked.
- (2) The Social Security (Rate of Young Parent Payment) Order 2012 (SR 2012/418) is revoked.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 April 2013, increases a range of benefits, allowances, asset limits, superannuation entitlements, etc. The increases reflect both mandatory adjustments and some additional discretionary increases. Where an annual CPI increase is

required, it reflects the increase of 0.61% in the New Zealand Consumers Price Index from the December 2011 quarter to the December 2012 quarter, calculated for all quarters using the CPI All Groups excluding cigarettes and other tobacco products.

Annual CPI increases are required under section 61HA of the Social Security Act 1964 for the following benefits: widows', orphans' and unsupported child's', invalids', unemployment, sickness, domestic purposes, child disability, disability, youth payments and young parent payments, related emergency benefits, and the hospital rate. These increases are set out in *Part 1 of Schedule 1*.

Annual CPI increases are also required, under section 15 of the New Zealand Superannuation and Retirement Income Act 2001, to superannuation entitlements. Section 16 of that Act requires that those increases may be more than the CPI amount in certain cases. The total of the increases required by both sections 15 and 16 is set out in *Part 2 of Schedule 1*.

The discretionary increases made under section 61H of the Social Security Act 1964 are to the funeral grant payable under that Act (*clause 3*), and schedules that set out the maximum amount that a blind beneficiary may earn, and various assets limits. The increases are set out in *Part 1 of Schedule 2*. Increases to superannuation entitlements, which build on the increases set out in *Part 2 of Schedule 1*, are also made, in order to implement the Government's commitment to ensure that the net married couple rate of New Zealand superannuation is set at 66% of the net average wage. These increases are set out in *Part 2 of Schedule 2*. The rates of New Zealand superannuation that are amended in all cases are the gross rates, but the increase has been calculated in relation to the net rate in each case.
