#### Order

#### 1 Title

This order is the State Sector (Employees of Boards of Waihopai School and Ruru Special School) Order 2006.

#### 2 Commencement

This order comes into force on 6 October 2006.

- (b) the transfer from the board of Ruru Special School to the Ministry of Education of the function of delivering specialist and therapy services for education centres, and primary, composite, and secondary schools, in the Ministry's Southland special education district.
