# Number of weeks over which a person's weekly income is to be determined under section 64(2A) of the Social Security Act 1964

#### Regulations

#### 1 Title and commencement

- (1) These regulations may be cited as the Social Security (Period of Income Assessment) Regulations 1996.
- (2) These regulations shall come into force on 1 July 1996.

#### 2 Period over which income to be calculated

- (1) For the purposes of determining the weekly income of any person in accordance with section 64(2A) of the Social Security Act 1964, the number of weeks over which that income is to be determined shall be the appropriate number of weeks set out in the Schedule of these regulations.
- (2) Nothing in subclause (1) shall prevent the chief executive, with the agreement of any person whose income would otherwise be determined over 52 weeks, determining that person's income over the period of 1 week.
- (3) An agreement with a person under subclause (2) may be ended by the person or by the chief executive at any time by notice to the other.
