## **Takeovers (Fees) Amendment Regulations 2001**

(SR 2001/390)

Takeovers (Fees) Amendment Regulations 2001: revoked, on 29 October 2018, pursuant to regulation 7 of the Takeovers Code Approval Amendment Regulations 2018 (LI 2018/183).

Pursuant to section 46 of the Takeovers Act 1993, Her Excellency the Governor-General, acting on the advice and with the consent of the Executive Council, makes the following regulations.

#### **1 Title**

- (1) These regulations are the Takeovers (Fees) Amendment Regulations 2001.
- (2) In these regulations, the Takeovers (Fees) Regulations 2001<sup>1</sup> are called “the principal regulations”.

#### **2 Commencement**

These regulations come into force on 15 January 2002.

#### **3 New regulation 5A inserted**

The principal regulations are amended by inserting, after regulation 5, the following regulation:

These regulations, which come into force on 15 January 2002, amend the Takeovers (Fees) Regulations 2001.
