This order, which comes into force on the 28th day after the date of its notification in the *Gazette*, declares that Orbitel Communications Limited and Auckland Independent Television Services Limited are network operators for the purposes of the Telecommunications Act 1987.

The order also revokes the network operator status of Telecable Holdings Limited, Multi Band Television Limited, Comsys Limited, Ashburton CA TV Limited, and Pacificom Networks Limited. These companies no longer require network operator status.
