1 Title and commencement

(1) This order may be cited as the Transport Organisation Membership Regulations Revocation Order 1984.

(2) This order shall come into force on the 1st day of June 1984.

2 Revocations

- (1) The Transport Organisation Membership Regulations 1941¹ are hereby revoked; and all approvals and notices given by the Minister under those regulations, and any conditions deemed to be part of any transport licence by regulation 4(2) of those regulations, shall cease to have effect accordingly.
- (2) The Transport Organisation Membership Regulations 1941, Amendment No 1² and the Transport Organisation Membership Regulations 1941, Amendment No 2³ are hereby consequentially revoked.
