1 Title

- (1) This notice is the Transport (Vehicle Registration and Licensing) Amendment Notice 2002.
- (2) In this notice, the Transport (Vehicle Registration and Licensing) Notice 1995 (SR 1995/136) is called “the principal notice”.

2 Commencement

This notice comes into force on 18 July 2002.

3 Form of registration plates (other than personalised registration plates or trade plates)

Clause 2(3)(b) of the principal notice is amended by adding the expression “; or” and also by adding the following subparagraph:

- “(iv) a series of numerals from 1 to 999 (both numbers inclusive) preceded and followed by a letter:”.

Explanatory note

This notice, which comes into force on 18 July 2002, amends the Transport (Vehicle Registration and Licensing) Notice 1995 by adding a provision that enables the use of a new numbering series for registration plates for trailers.
