Transport (Vehicle Registration and Licensing) Amendment Notice 2006:  
revoked, on 1 May 2011, pursuant to regulation 97(c) of the Land Transport  
(Motor Vehicle Registration and Licensing) Regulations 2011 (SR 2011/79).

**1 Title**

This notice is the Transport (Vehicle Registration and Licensing) Amendment Notice 2006.

**2 Commencement**

This notice comes into force on 22 January 2007.

**3 Principal notice amended**

This notice amends the Transport (Vehicle Registration and Licensing) Notice 1995.

**4 Form of registration plates (other than personalised registration plates or trade plates)**

(1) Clause 2(3)(a) is amended by omitting “:” and substituting “; or”, and also by adding the following subparagraphs:

“(iv) a letter, followed by a numeral from 1 to 9 (both numbers inclusive), followed by any combination of 3 letters; or

“(v) a letter, followed by a numeral from 1 to 9 (both numbers inclusive), above any combination of 3 letters:”.

(2) Clause 2 is amended by adding the following subclause:

“(5) To avoid doubt, nothing in subclause (3)(a) or (b) permits distinguishing marks on a registration plate to be assigned (whether in the same or a in different format) to more than 1 vehicle.

**Example**

A registration plate with the following distinguishing marks is assigned to a vehicle:

A1ABC

A registration plate with the following distinguishing marks cannot, therefore, be assigned to another vehicle:

A1

ABC

### **Explanatory note**

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice, which comes into force on 22 January 2007, amends clause 2(3)(a) of the Transport (Vehicle Registration and Licensing) Notice 1995 by adding 2 new subparagraphs, which enable the use of the following combinations of letters and numerals on registration plates for motor cycles, mopeds, and tractors:

- any letter, followed by any numeral from 1 to 9 (both numbers inclusive), followed by any combination of 3 letters; or
- any letter, followed by any numeral from 1 to 9 (both numbers inclusive), above any combination of 3 letters.

This notice also inserts a *new subclause (5)* into clause 2, which makes clear that distinguishing marks on a registration plate assigned to a vehicle in 1 of the formats permitted under subclause (3)(a) or (b), cannot be assigned to another vehicle, whether in the same or in a different format.
