## Notice

## 1 Title and commencement

(1) This notice may be cited as the Transport (Vehicle Registration and Licensing) Notice 1995.
(2) This notice shall come into force on 1 July 1995.

2 Form of registration plates (other than personalised registration plates or trade plates)
(1) This clause applies to a registration plate other than a personalised registration plate or trade plate.
(2) The distinguishing marks on a registration plate shall be-
(a) embossed, and coloured aluminium on a black background; or
(b) embossed, and coloured black against a reflective background consisting of white retro-reflective sheeting,and the base material of a registration plate shall be aluminium.
(3) The distinguishing marks for a registration plate shall be,-
(a) in the case of plates for motorcycles, mopeds, and trac-tors,-
(i) a series of numerals from 1 to 99999 (both numbers inclusive); or
(ii) a series of numerals from 1 to 999 (both numbers inclusive) followed by any combination of 2 or 3 letters; or
(iii) a series of numerals from 1 to 99 (both numbers inclusive) above any combination of 3 letters; or
(iv) a letter, followed by a numeral from 1 to 9 (both numbers inclusive), followed by any combination of 3 letters; or
(v) a letter, followed by a numeral from 1 to 9 (both numbers inclusive), above any combination of 3 letters:
(b) in the case of plates for trailers,-
(i) a series of numerals from 1 to 99999 (both numbers inclusive); or
(ii) a series of numerals from 1 to 9999 (both numbers inclusive) preceded or followed by a letter; or
(iii) a series of numerals from 1 to 999 (both numbers inclusive) followed by any combination of 2 or 3 letters; or
(iv) a series of numerals from 1 to 999 (both numbers inclusive) preceded and followed by a letter:
(c) in the case of plates for any motor vehicle not referred to in paragraph (a) or paragraph (b), -
(i) any combination of 2 letters, followed by any of the numbers from 1 to 9999 (inclusive), or
(ii) any combination of 3 letters, followed by any of the numbers from 1 to 999 (inclusive).
(4) No combination of letters and numerals shall be used on any registration plate under subclause (3) if that combination of letters or numerals appears or is to appear on-
(a) a personalised registration plate; or
(b) a trade plate.
(5) To avoid doubt, nothing in subclause (3)(a) or (b) permits distinguishing marks on a registration plate to be assigned (whether in the same or a in different format) to more than 1 vehicle.

## 3 Form of personalised registration plates

(1) The distinguishing marks on a personalised registration plate shall be embossed, and coloured black or red or blue, as the case may be, against a reflective background consisting of white retro-reflective sheeting.
(2) Any subsidiary characters, messages, symbols, or slogans that have been approved by the Registrar for display on a personalised registration plate under section 9E(2)(a) of the Transport (Vehicle and Driver Registration and Licensing) Act 1986, may be of any colour.
(3) The base material of a personalised registration plate shall be aluminium.

## 4 Form of trade plates

## 5 Registration plates for official vehicles

Notwithstanding anything in clauses 2 to 4, the registration plates of any motor vehicle that is the property of or regularly used by the Governor-General, and any motor vehicle that is operated or regularly used by a government, person, or organisation described in the first column of the table, shall be distinguished solely by the symbol or, as the case may be, the letters and numbers specified in the second column of that table.

1 Governor-General
2 (a) Governments of foreign and Commonwealth countries with established diplomatic missions in New Zealand.
(b) Any person entitled in New Zealand to full diplomatic immunities and privileges under the Diplomatic Privileges and Immunities Act 1968.
(c) Organisations in respect of which immunities and privileges have been conferred under section 9 (2)(a) of the Diplomatic Privileges and Immunities Act 1968.
(d) Any person entitled in New Zealand to immunities and privileges under section $9(2)(b)$ of the Diplomatic Privileges and Immunities Act 1968.

6 Affixing of registration plates (other than trade plates)
Registration plates issued for a motor vehicle shall be displayed as follows:
(a) in the case of a motor vehicle other than a motor vehicle of any of the kinds specified in paragraph (b), one plate shall be displayed on the front of the vehicle and one plate shall be displayed on the rear of the vehicle, and both plates shall be in an upright position and so displayed that every letter, figure, and distinguishing mark on the plate is easily visible:
(b) in the case of any motorcycle, moped, tractor, or trailer, one plate shall be displayed on the rear of the vehicle in an upright position and so displayed that every letter, figure, and distinguishing mark on the plate is easily visible.

## 7 Affixing of trade plates

## 7A Combined trade plate and licence

A trade licence under section 34 of the Transport (Vehicle and Driver Registration and Licensing) Act 1986-
(a) must be in the form of Diagram No 4 of Schedule 1; and
(b) must be made as an aluminium plate with a yellow retroreflective background, bearing, embossed in black,-
(i) the letter "X", preceded or followed by 4 numerals; and
(ii) the last 2 digits of the year of its issue, arranged vertically to the right of the letter and numerals; and
(c) serves also as the trade plate for the motor vehicle in respect of which it is issued.
Clause 7A: inserted, on 22 July 1999, by clause 3(1) of the Transport (Vehicle Registration and Licensing) Amendment Notice 1999 (SR 1999/204).

8 Form of licences (other than trade licences)
(1) This clause applies to licences to use motor vehicles but does not apply to trade licences.
(2) Subject to subclause (3), the licence for any motor vehicle must be in the form of Diagram No 2A or Diagram No 3 of Schedule 1.
(3) The large letter "G" in Diagram No 2A or Diagram No 3 of Schedule 1 must be replaced, in the same style,-
(a) in the case of the licence for a motor vehicle operated under a transport service licence (other than a vehicle to which paragraph (c) or paragraph (d) applies),-
(i) if current evidence of vehicle inspection is required for the vehicle but not a certificate of loading, by the letter "T" (representing the licence class); and
(ii) if current evidence of vehicle inspection and a certificate of loading is required for the vehicle, by the letter " L " (representing the licence class):
(b) in the case of the licence for a heavy motor vehicle for which current evidence of vehicle inspection is required (other than a heavy vehicle to which any of paragraphs (a), (c), and (d) applies), by the letter " K " (representing the licence class):
(c) in the case of the licence for a motor vehicle described in Part 2 of Schedule 1 of the Transport (Vehicle Registration and Licensing) Regulations 1994 (which relates to vehicles exempted from registration and licensing fees), by the letter "A" (representing the licence class):
(d) in the case of the licence for an exempted vehicle within the meaning of regulations referred to in section 45 of the Land Transport Management Act 2003,-
(i) if current evidence of vehicle inspection is required for the vehicle, by the letter "B" (representing the licence class); and
(ii) if current evidence of vehicle inspection is not required for the vehicle, by the letter " X ":
(e) in the case of the licence for a motor vehicle not referred to in any of paragraphs (a) to (d) for which current evidence of vehicle inspection is not required, by the letter " N " (representing the licence class).
(4) In respect of any licence in the form of Diagram No 2 A or Diagram No 3 of Schedule 1-
(a) if the licence is issued in respect of an expiry day, expiry month, expiry year, or licence number other than that shown in the diagram, the appropriate details shall appear in place of those shown:
(b) if the vehicle for which the licence is issued differs from that shown in the diagram in respect of year or month first registered in New Zealand, registration number, year in which the vehicle was made, or the manufacturer or model, the appropriate identifying details shall appear in place of those shown:
(c) if, and only if, at the time of application for the licence the vehicle is one which is required also to be licensed under the Road User Charges Act 1977, the licence shall show the letters "RUC" as indicated in the diagram:
(d) [Revoked]
(e) the licence shall show a stripe that is coloured blue:
(f) the label number, bar coding, print batch, and time and date that the licence is printed may vary from those shown in the diagram.

9 Form of trade licences
[Revoked]

## 10 Display of licences (other than trade licences)

(1) This clause applies to licences to use motor vehicles but does not apply to trade licences.
(2) A licence issued for a vehicle shall be displayed as follows:
(a) if the vehicle is a motorcycle, moped, tractor, or trailer, the licence must be affixed-
(i) to the registration plate on the right-hand side; or
(ii) to the vehicle, immediately below or as close as is practicable to the registration plate:
(b) [Revoked]
(c) if the vehicle is not a motorcycle, moped, tractor, or trailer, and is fitted with a windscreen, the licence must be displayed on the inside of the windscreen, as close as is practicable to the bottom right-hand corner of the windscreen (when viewed from the outside and front of the vehicle):
(d) [Revoked]
(e) if the vehicle is not a motorcycle, moped, tractor, or trailer, and is not fitted with a windscreen, the licence must be affixed to the back of the vehicle, as close as is practicable to the registration plate.
(3) In every case the licence shall be displayed in an upright easily visible position.

11 Affixing of trade licences
A trade licence must be affixed on the rear of the motor vehicle concerned-
(a) in an upright position; and
(b) so that every letter, figure, and distinguishing mark on it is easily visible; and
(c) so that it is not readily detachable from the vehicle.

12 Fees
(1) The fees specified in Schedule 2 shall be payable to the Registrar in respect of the matters to which they relate.
(2) For the purposes of this clause and the matters set out in Schedule 2,-
(a) standard issue personalised registration plate means a personalised registration plate that consists solely of distinguishing marks embossed, and coloured black against a reflective background of white retro-reflective sheeting:
(b) special issue personalised registration plate means a personalised registration plate other than a standard issue personalised registration plate.
(3) The fees payable under subclause (1) are inclusive of any goods and services tax payable under the Goods and Services Tax Act 1985.
