This order revokes regulations relating to registration and licensing of motor vehicles, and 2 other regulations. The matters formerly dealt with in the Motor Vehicles Registration and Licensing Regulations 1965 are now dealt with in Part 2 of the Transport Act 1962 as amended earlier this year, and in Ministerial prescriptions under section 14A of that Act.

The revocation of the 2 other regulations is consequential upon the revocation of the Motor Vehicles Registration and Licensing Regulations 1965, recent amendments to the Transport Act 1962, and the new Transport (Drivers Licensing) Regulations 1985.
