# Regulations

#### 1 Title and commencement

- (1) These regulations may be cited as the Unit Trusts (Fees) Regulations 1999.
- (2) These regulations come into force on 1 July 1999.

## 2 Interpretation

In these regulations, unless the context otherwise requires, the term **the Act** means the Unit Trusts Act 1960.

#### 3 Fees

- (1) The fees set out in the Schedule are payable to the Registrar in respect of the matters to which they relate.
- (2) Where the Registrar is empowered by the Act to do any act for which a fee is payable, the Registrar may refuse to do that act until the fee has been paid.
- (3) The fees prescribed by these regulations are inclusive of goods and services tax.

#### 4 Revocation

The Unit Trusts (Fees) Regulations 1996 (SR 1996/38) are consequentially revoked.

# **Explanatory note**

This note is not a part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 July 1999, replace the Unit Trusts (Fees) Regulations 1996. The regulations reduce from \$200 to \$100 the fee for lodging an authenticated copy of a trust deed under section 9(1) of the Unit Trusts Act 1960.

The fees are inclusive of goods and services tax.
