## Regulations

### 1 Title

These regulations are the Veterans' Support Amendment Regulations 2016.

### 2 Commencement

These regulations come into force on 24 March 2016.

### **Explanatory note**

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 24 March 2016, amend the Veterans' Support Regulations 2014 (the **principal regulations**). These regulations amend Schedule 1 of the principal regulations, which lists the Australian statements of principles that apply to specified medical conditions. The amendments insert 1 new condition, remove 1 condition, and replace statements of principles references for 10 conditions.
