### 1 Title

These regulations are the Veterans' Support Amendment Regulations (No 3) 2016.

### Explanatory note

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 30 June 2016, amend the Veterans' Support Regulations 2014 (the **principal regulations**).

These regulations amend Schedule 1 of the principal regulations, which lists the Australian statements of principles that apply to specified medical conditions.

The amendments insert 1 new condition and replace statements of principles references for 13 conditions.
