## Building Amendment Bill

### *Proposed amendments*

Hon Jenny Salesa, in Committee, to move the following amendments:

#### *Clause 12*

In *clause 12, new section 133BB(1)*, definition of **relevant CDEM decision-maker**, *paragraph (b)*, replace “**sections 133BG, 133BH, and 133BI**” (page 8, line 8) with “**sections 133BG and 133BH**”.

In *clause 12, new section 133BH(1)(c)(ii)*, before “the territorial authority” (page 12, line 18), insert “with the Minister’s approval”.

In *clause 12, new section 133BJ(1)*, after “**133BW**” (page 13, line 25), insert “**and 133BZ**”.

In *clause 12, new section 133BJ(5)(b)*, after “**133BW**” (page 14, line 8), insert “**and 133BZ**”.

In *clause 12, new section 133BK(1)*, after “**133BW**” (page 14, line 15), insert “**and 133BZ**”.

In *clause 12, new section 133BK(2)(c)*, before “may” (page 14, line 38), insert “or **section 133BZ(3)(a)** (bring forward due date for provision of assessment or information)”.

In *clause 12, new section 133BK(2)(d)*, replace “, or **section 133BW** (works for long-term use or occupation of building)” (page 15, lines 6 and 7) with “, **section 133BW** (works for long-term use or occupation of building), or **section 133BZ(3)(b)** (bring forward deadline for completing seismic work)”.

In *clause 12, new section 133BL(2)*, replace “powers under **sections 133BP to 133BW**” (page 15, line 35) with “a power under any of **sections 133BP to 133BW and 133BZ**”.

In *clause 12, new section 133BN*, after “**133BW**” (page 16, line 24), insert “**and 133BZ**”.

In *clause 12, new section 133BO*, after “**133BW**” (page 17, line 22), insert “**and 133BZ**”.

In *clause 12, new section 133BP(7)*, replace “**(6)(b)**” (page 18, line 27) with “**(6)**”.

### Explanatory note

This Supplementary Order Paper amends the Building Amendment Bill by—

- inserting in *new section 133BH(1)(c)(ii)* a reference to the requirement that the territorial authority extend the designation referred to only with the Minister’s approval (consistent with *new section 133BH(1)(b)* and *new section 133BC(2)(a)*); and
- amending *new section 133BK(2)(c)* to provide that the power under *new section 133BZ(3)(a)* may be exercised by the Director or the relevant CDEM Group appointed under the Civil Defence Emergency Management Act 2002 (**CDEM Act**); and
- amending *new section 133BK(2)(d)* to provide that the power under *new section 133BZ(3)(b)* may be exercised by the relevant CDEM Group or a Recovery Manager appointed under the CDEM Act; and
- correcting cross-references in *new sections 133BB(1)* (definition of **relevant CDEM decision-maker**), *133BJ(1)*, *133BJ(5)(b)*, *133BK(1)*, *133BL(2)*, *133BN*, *133BO*, and *133BP(7)*.
