Courts and Criminal Matters Bill

---

*Proposed motion to divide Bill into 21 Bills*

Hon Georgina te Heuheu, in Committee, to move as follows:

That the enacting words, *clauses 1 and 2, Part 1, and Schedule 1* be a separate Bill, and that for the enacting words, *clauses 1 and 2*, and the *Part 1* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the District Courts Amendment Act **2010**.

**2 Commencement**

- (1) **Sections 3 and 5 to 7A** come into force on the day after the date on which this Act receives the Royal assent.
- (2) The rest of this Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.

That *Part 2* be a separate Bill, and that for the *Part 2* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Land Transport Amendment Act **2010**.

**2 Commencement**

- (1) **Sections 39, 42, 44, 45, and 47(1AA) and (1)** come into force on the day after the date on which this Act receives the Royal assent.

- (2) The rest of this Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.

That *Part 3* and *Schedules 2 to 2B* be a separate Bill, and that for the *Part 3* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Summary Proceedings Amendment Act **2010**.

**2 Commencement**

- (1) The following provisions come into force on the day after the date on which this Act receives the Royal assent:
- (a) **section 51**;
  - (b) **section 63**;
  - (c) **section 67** (but only to the extent that it relates to **section 88B** of the Summary Proceedings Act 1957);
  - (d) **section 69** (but only to the extent that it relates to **section 92I** of the Summary Proceedings Act 1957);
  - (e) **section 77**.
- (2) The rest of this Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.
- (3) Any provisions of this Act that are not in force on the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent come into force (despite **subsection (2)**) on that expiry.

That *subpart 1 of Part 4* be a separate Bill, and that for the *Part 4* heading and *subpart 1* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Children, Young Persons, and Their Families Amendment Act **2010**.

**2 Commencement**

- (1) This Act (except **section 79A**) comes into force on the day after the date on which it receives the Royal assent.
- (2) **Section 79A** comes into force on the earlier of—
- (a) a date appointed by the Governor-General by Order in Council; and

- (b) the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent.

That *subpart 1A of Part 4* be a separate Bill, and that for the *subpart 1A* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Crimes Amendment Act **2010**.

**2 Commencement**

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provisions of this Act that are not in force on the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent come into force (despite **subsection (1)**) on that expiry.

That *subpart 1B of Part 4* be a separate Bill, and that for the *subpart 1B* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Criminal Proceeds (Recovery) Amendment Act **2010**.

**2 Commencement**

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provisions of this Act that are not in force on the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent come into force (despite **subsection (1)**) on that expiry.

That *subpart 2 of Part 4* be a separate Bill, and that for the *subpart 2* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Customs and Excise Amendment Act **2010**.

**2 Commencement**

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provisions of this Act that are not in force on the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent come into force (despite **subsection (1)**) on that expiry.

That *subpart 2A of Part 4* be a separate Bill, and that for the *subpart 2A* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Disputes Tribunals Amendment Act **2010**.

**2 Commencement**

This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.

That *subpart 3 of Part 4* be a separate Bill, and that for the *subpart 3* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Family Courts Amendment Act **2010**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 5 of Part 4* be a separate Bill, and that for the *subpart 5* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Immigration Amendment Act **2010**.

**2 Commencement**

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.

- (2) Any provisions of this Act that are not in force on the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent come into force (despite **subsection (1)**) on that expiry.

That *subpart 5A of Part 4* be a separate Bill, and that for the *subpart 5A* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

That *subpart 5B of Part 4* be a separate Bill, and that for the *subpart 5B* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Misuse of Drugs Amendment Act 1978 Amendment Act **2010**.

**2 Commencement**

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provisions of this Act that are not in force on the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent come into force (despite **subsection (1)**) on that expiry.

That *subpart 6 of Part 4* be a separate Bill, and that for the *subpart 6* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Personal Property Securities Amendment Act **2010**.

**2 Commencement**

This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.

That *subpart 7 of Part 4* be a separate Bill, and that for the *subpart 7* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Prisoners' and Victims' Claims Amendment Act **2010**.

**2 Commencement**

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provisions of this Act that are not in force on the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent come into force (despite **subsection (1)**) on that expiry.

That *subpart 8 of Part 4* and *Schedule 3* be a separate Bill, and that for the *subpart 8* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Privacy Amendment Act **2010**.

**2 Commencement**

This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.

That *subpart 9 of Part 4* be a separate Bill, and that for the *subpart 9* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Railways Amendment Act **2010**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 9A of Part 4* be a separate Bill, and that for the *subpart 9A* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Residential Tenancies Amendment Act **2010**.

**2 Commencement**

This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.

That *subpart 10 of Part 4* be a separate Bill, and that for the *subpart 10* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Sentencing Amendment Act **2010**.

**2 Commencement**

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provisions of this Act that are not in force on the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent come into force (despite **subsection (1)**) on that expiry.

That *subpart 11 of Part 4* be a separate Bill, and that for the *subpart 11* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Social Security Amendment Act **2010**.

**2 Commencement**

- (1) This Act (except **section 113(2)**) comes into force on the day after the date on which it receives the Royal assent.
- (2) **Section 113(2)** comes into force on the earlier of—
  - (a) a date appointed by the Governor-General by Order in Council; and
  - (b) the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent.

That *subpart 12 of Part 4* be a separate Bill, and that for the *subpart 12* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Tax Administration Amendment Act **2010**.

**2 Commencement**

- (1) This Act (except **section 115(7)**) comes into force on the day after the date on which it receives the Royal assent.
- (2) **Section 115(7)** comes into force on the earlier of—
  - (a) a date appointed by the Governor-General by Order in Council; and
  - (b) the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent.

That *subpart 13 of Part 4* be a separate Bill, and that for the *subpart 13* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Transport Amendment Act **2010**.

**2 Commencement**

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provisions of this Act that are not in force on the expiry of the period of 15 months that starts on the date on which this Act receives the Royal assent come into force (despite **subsection (1)**) on that expiry.
