### **Electricity Industry Amendment Bill**

Proposed amendments

Hon Dr Megan Woods, in Committee, to move the following amendments:

Clause 2

In clause 2 (page 4, after line 6), insert as subclause (2):

(2) However, **section 9** comes into force 4 months after the date on which this Act receives the Royal assent.

New clause 32A

After clause 32 (page 17, after line 2), insert:

# **32A** Section 102 amended (Procedures for annual meeting to appoint auditor)

After section 102(4), insert:

(5) Beneficiaries may attend and vote at an annual meeting in person or, subject to the approval of the trustees, by audio link, audiovisual link, or other remote access facility.

Schedule 1: new Schedule 1

In Schedule 1, new Schedule 1, after clause 6 (page 25, after line 4), insert:

### 7 References to Authority's objectives

- (1) This clause applies before the commencement of **section 9** of the amendment Act.
- (2) A reference in this Act to the Authority's objectives under section 15 must be read as a reference to the objective set out in section 15 before the commencement of **section 9** of the amendment Act.

### **Explanatory note**

This Supplementary Order Paper makes 2 main amendments to the Electricity Industry Amendment Bill (the **Bill**). Those changes are as follows:

- amending *clause 2* (commencement) to provide for *clause 9* to come into force 4 months after the date on which the Bill receives the Royal assent. *Clause 9* amends section 15 of the Electricity Industry Act 2010 (the **Act**), which relates to the objective of the Electricity Authority. *Clause 9* is the only clause that is proposed to have a delayed commencement, with the remainder of the Bill coming into force on the day after the date of Royal assent:
- inserting a *new clause 32A*, which amends section 102 of the Act. Section 102 relates to the procedures for an annual meeting of the beneficiaries of a customer or community trust. The amendment provides that beneficiaries may attend and vote at such a meeting in person or, subject to the approval of the trustees, remotely (for example, by audio link).

A minor addition is also made to the transitional provisions in *Schedule 1* of the Bill, relating to the commencement of *clause 9*.

#### **Departmental disclosure statement**

The Ministry of Business, Innovation, and Employment is required to prepare a disclosure statement to assist with the scrutiny of this Supplementary Order Paper.
