**Regulatory Reform Bill**

---

*Proposed motion to divide Bill into 13 Bills*

Hon John Banks, in Committee, to move as follows:

That the enacting words, *clauses 1 and 2*, and *Part 1* be a separate Bill, and that for the enacting words, *clauses 1 and 2*, and the *Part 1* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Agricultural Compounds and Veterinary Medicines Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 2* be a separate Bill, and that for the *Part 2* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Animal Products Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 3* be a separate Bill, and that for the *Part 3* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Companies Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 4* be a separate Bill, and that for the *Part 4* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Conservation Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 5* and the *Schedule* be a separate Bill, and that for the *Part 5* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Films, Videos, and Publications Classification Amendment Act **2012**.

**2 Commencement**

This Act comes into force on **1 July 2012**.

That *Part 6* be a separate Bill, and that for the *Part 6* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Fisheries Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 7* be a separate Bill, and that for the *Part 7* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Friendly Societies and Credit Unions Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 8* be a separate Bill, and that for the *Part 8* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Radiocommunications Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 9* be a separate Bill, and that for the *Part 9* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Registered Architects Amendment Act **2012**.

**2 Commencement**

This Act comes into force 1 year after the date on which it receives the Royal assent unless it is earlier brought into force on a date appointed by the Governor-General by Order in Council.

That *Part 10* be a separate Bill, and that for the *Part 10* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Statistics Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 11* be a separate Bill, and that for the *Part 11* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Takeovers Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 12* be a separate Bill, and that for the *Part 12* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Unit Trusts Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 13* be a separate Bill, and that for the *Part 13* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Wine Amendment Act **2012**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.
