Proposed amendments

Explanatory note

This Supplementary Order Paper—

- makes changes to provisions concerning the issue of search warrants to enforcement officers and customs officers to clarify that the references to "Justice" and "Registrar" in those provisions are references to a Justice of the Peace and a Registrar of a District Court:
- provides for forms to be prescribed for
 - applications that may be made by enforcement officers and customs officers for search warrants and orders to produce documents:
 - orders to produce documents.
