Customs and Excise (Tobacco Products—Budget
Measures) Amendment Bill

Proposed motion to divide Bill into 7 Bills

Hon Tariana Turia, in Committee, to move as follows:

That the enacting words, *clauses 1 to 3*, and *Part 1* be a separate Bill, and that the enacting words, *clauses 1 to 3*, and the *Part 1* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Customs and Excise (Tobacco Products—Budget Measures) Amendment Act **2012**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

3 Principal Act

This Act amends the Customs and Excise Act 1996 (the **principal Act**).

That *Part 2* (except for *clauses 8 to 13* and the cross-headings above *clauses 8, 9, 10, 11, and 13*) be a separate Bill, and that the *Part 2* heading and the cross-heading above *clause 7* be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Children, Young Persons, and Their Families (Indexation—Budget Measures) Amendment Act **2012**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *clause 8* and the cross-heading above that clause be a separate Bill, and that the cross-heading be replaced with:

The Parliament of New Zealand enacts as follows:**1 Title**

This Act is the Education (Student Allowances Indexation—Budget Measures) Amendment Act **2012**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *clause 9* and the cross-heading above that clause be a separate Bill, and that the cross-heading be replaced with:

The Parliament of New Zealand enacts as follows:**1 Title**

This Act is the Income Tax (Working for Families Indexation—Budget Measures) Amendment Act **2012**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *clause 10* and the cross-heading above that clause be a separate Bill, and that the cross-heading be replaced with:

The Parliament of New Zealand enacts as follows:**1 Title**

This Act is the New Zealand Superannuation and Retirement Income (Indexation—Budget Measures) Amendment Act **2012**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *clauses 11 and 12* and the cross-heading above *clause 11* be a separate Bill, and that the cross-heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Social Security (Indexation—Budget Measures) Amendment Act **2012**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *clause 13* and the cross-heading above that clause be a separate Bill, and that the cross heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the War Pensions (Indexation—Budget Measures) Amendment Act **2012**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.
