**Statutes Amendment Bill (No 2)**

---

*Proposed motion to divide Bill into 14 Bills*

Hon Lianne Dalziel, in Committee, to move as follows:

That the enacting words, *clauses 1 and 2*, and *Part 1* be a separate Bill, and that for the enacting words, *clauses 1 and 2*, and the *Part 1* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Biosecurity Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 2* be a separate Bill, and that for the *Part 2* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Cadastral Survey Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 3* be a separate Bill, and that for the *Part 3* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Crimes Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 4* be a separate Bill, and that for the *Part 4* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Criminal Investigations (Bodily Samples) Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 5* be a separate Bill, and that for the *Part 5* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the District Courts Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 6* be a separate Bill, and that for the *Part 6* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Fisheries Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 7* be a separate Bill, and that for the *Part 7* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Historic Places Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 8* be a separate Bill, and that for the *Part 8* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Misuse of Drugs Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 9* be a separate Bill, and that for the *Part 9* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the National Parks Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 10* be a separate Bill, and that for the *Part 10* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the New Zealand Horticulture Export Authority Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 11* be a separate Bill, and that for the *Part 11* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Radiocommunications Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 12* be a separate Bill, and that for the *Part 12* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Reserves Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 13* be a separate Bill, and that for the *Part 13* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Summary Proceedings Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 14* be a separate Bill, and that for the *Part 14* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Veterinarians Amendment Act **2008**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.
