**Statutes Amendment Bill (No 2)**

*Proposed motion to divide Bill into 20 Bills*

Hon Nathan Guy, in Committee, to move as follows:

That the enacting words, *clauses 1 and 2*, and *Part 1* be a separate Bill, and that for the enacting words, *clauses 1 and 2*, and the *Part 1* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Antarctica (Environmental Protection) Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 2* be a separate Bill, and that for the *Part 2* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Charities Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 3* be a separate Bill, and that for the *Part 3* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Citizens Initiated Referenda Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 4* be a separate Bill, and that for the *Part 4* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Civil Defence Emergency Management Amendment Act **2011**.

**2 Commencement**

This Act comes into force 30 days after the date on which this Act receives the Royal assent.

That *Part 5* be a separate Bill, and that for the *Part 5* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Companies Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 6* be a separate Bill, and that for the *Part 6* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Crimes Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 7* be a separate Bill, and that for the *Part 7* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Criminal Proceeds (Recovery) Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 8* be a separate Bill, and that for the *Part 8* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Domestic Violence Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 9* be a separate Bill, and that for the *Part 9* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Judicature Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 10* be a separate Bill, and that for the *Part 10* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Limited Partnerships Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 11* and the *Schedule* be a separate Bill, and that for the *Part 11* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Marriage Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 12* be a separate Bill, and that for the *Part 12* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Mutual Assistance in Criminal Matters Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 13* be a separate Bill, and that for the *Part 13* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the New Zealand Railways Corporation Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 14* be a separate Bill, and that for the *Part 14* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the New Zealand Superannuation and Retirement Income Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 15* be a separate Bill, and that for the *Part 15* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Public Finance Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 16* be a separate Bill, and that for the *Part 16* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Social Security Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 17* be a separate Bill, and that for the *Part 17* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Sugar Loaf Islands Marine Protected Area Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 18* be a separate Bill, and that for the *Part 18* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Trade Marks Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 19* be a separate Bill, and that for the *Part 19* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Wild Animal Control Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 20* be a separate Bill, and that for the *Part 20* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:****1 Title**

This Act is the Wills Amendment Act **2011**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.
