New clause 30A

After clause 30 (after line 7 on page 23), insert:

30A Amendments relating to Legislation Act 2012

- (1) This section takes effect on the repeal of the Acts and Regulations Publication Act 1989 and the Regulations (Disallowance) Act 1989.
- (2) This Act is amended in the manner set out in the **Schedule**.

Amendments relating to Legislation Act 2012

Section 13(3)

Repeal and substitute:

"(3) An order under **subsection (1)** and an exemption under **subsection (2)** are legislative instruments and disallowable instruments for the purposes of the Legislation Act 2012 and must be presented to the House of Representatives under section 40 of that Act."

Section 15(2)

Repeal and substitute:

"(2) An order under **subsection (1)** and an order under **subsection (1A)** are legislative instruments and disallowable instruments for the purposes of the Legislation Act 2012 and must

Section 15(2)—continued

be presented to the House of Representatives under section 40 of that Act."

Clause 18(5)

Repeal and substitute:

"(5) An order under **subsection (2)(a)** and an exemption under **subsection (3)** are legislative instruments and disallowable instruments for the purposes of the Legislation Act 2012 and must be presented to the House of Representatives under section 40 of that Act."

Clause 22(5)

Repeal and substitute:

"(5) An order under **subsection (2)(a)** and an exemption under **subsection (3)** are legislative instruments and disallowable instruments for the purposes of the Legislation Act 2012 and must be presented to the House of Representatives under section 40 of that Act."

Clause 25(2)

Repeal and substitute:

"(2) An order under **subsection (1)(a)** is a legislative instrument and a disallowable instrument for the purposes of the Legislation Act 2012 and must be presented to the House of Representatives under section 40 of that Act."

Explanatory note

This Supplementary Order Paper amends the Trade (Safeguard Measures) Bill. The amendments are consequential on the enactment of the Legislation Act 2012, which will repeal the Acts and Regulations Publication Act 1989 and the Regulations (Disallowance) Act 1989 and replace them with a broadly similar regime. Accordingly, this Supplementary Order Paper amends the Trade (Safeguard Measures) Bill by—

- replacing references to regulations with references to legislative instruments and disallowable instruments; and
- replacing references to the Regulations (Disallowance) Act 1989 with references to the Legislation Act 2012.
