

APPROPRIATION ORDINANCE, NO. 2, 1868.

IN THE THIRTY-FIRST YEAR OF THE REIGN OF HER MAJESTY QUEEN VICTORIA.

4. Provincial Treasurer shall be allowed credit for sums expended as per Schedule B from first day of January, 1868, to thirtieth day of April, 1868.

AN ORDINANCE to provide for the further Appropriation of the Title. Revenue for the period from the 1st January, 1868, to the 30th April, 1868, and for the further appropriation of the Revenue for the period from the 1st May, 1868, to the 30th June, 1868.

BE IT ENACTED by the Superintendent of the Province of Preamble. Southland with the advice and consent of the Provincial Council thereof as follows that is to say :---

1. The Short Title of this Ordinance shall be "The Appro-Short Title. priation Ordinance, No. 2, 1868."

2. Provincial Treasurer in pursuance of special warrants duly certified in the manner prescribed by the "Provincial Audit Act 1866" and such sums were paid on account of the services set forth in the Schedule B to this Ordinance but were not included in any Ordinance for the appropriation of the public revenue of the said Province And whereas this sum of seven hundred and seventy-three pounds sixteen shillings and eightpence does not exceed the amount which can be authorised by Special Orders under the said "Provincial Audit Act 1866" And whereas in terms of and in the manner prescribed by the 14th Clause of said "Provincial Audit Act, 1866" the Superintendent has recommended the Council to grant a sum of money sufficient for the purposes aforesaid Be it therefore enacted that the Provincial Treasurer shall be allowed creditin his accounts for all sums of money so issued and paid by him on the several accounts set forth in the schedule B hereunto annexed and the receipts of the persons to whom such sums of money shall have been paid under such warrants shall be a complete discharge for the sum or sums of money for which such receipts shall have been given.
