

## PROVINCIAL LIABILITIES CONFIRMATION ORDINANCE, 1865.

No. 64

## ANALYSIS:

Title. Preamble.

An Ordinance to confirm the engagements and liabilities made and Title incurred by the Superintendent of the Province of Southland and for other purposes.

WHEREAS under and by virtue of the provisions of the "Debentures Preamble. Ordinance 1863" of the Local Legislature of the Province of Southland the Superintendent of the said Province was authorised to raise by the sale of debentures as therein provided all such sum or sums of money not exceeding in the whole the sum of £140,000 as should be required for the construction of certain public works therein mentioned:

And whereas by the "Appropriation Ordinance No. 1 1863" of the said Local Legislature it is enacted that out of any moneys raised or to be raised by virtue of the said recited Ordinance there may be issued and applied in manner therein mentioned any sum not exceeding the sum of £140,000 to defray the expenses of the works therein mentioned: And whereas under and by virtue of the provisions of the "Debentures Ordinance No. 2 1863" the said Superintendent was authorised to raise by the sale of debentures as therein provided all such sum or sums of money not exceeding in the whole the sum of £110,000 as should be required for the construction of certain public works therein mentioned And whereas by the "Appropriation Ordinance No. 2" 1863 it is enacted that out of any moneys raised or to be raised by virtue of the said last recited Ordinance there may be issued or applied in manner thereinafter mentioned any sum not exceeding the sum of £110,000 to defray the expenses of the Public Works therein mentioned: And whereas under and by virtue of the provisions of the "Debentures Ordinance No. 1 1864" the said Superintendent was authorised to raise by the sale of Debentures as therein provided all such sum or sums of money not exceeding in the whole the sum of £40,000 as should be required for the construction of certain public works therein mentioned: And whereas by the Appropriation Ordinance No. 1 1864 it is enacted that out of any moneys raised or to be raised by virtue of the said last recited Ordinance there may be issued and applied in manner therein mentioned any sum not exceeding the sum of £40,000 to defray the expenses of the works therein mentioned: And whereas Debentures representing in the whole the several sums of £140,000 £110,000 and £40,000 have been issued under the authority of the said several Ordinances but no sales of such Debentures have been made: And whereas large sums of money have been advanced by certain Banking Corporations to the Superintendent of the said Province for the public service thereof upon the security of the said Debentures, which advances with interest are still outstanding and unpaid: And whereas the said Superintendent has incurred divers other liabilities for the public service of the said Province which are still unpaid: And whereas by the 3rd section of the "Southland Provincial Debt Act 1865" of the General Assembly of New Zealand it is enacted that upon the examination of any report of the person or persons appointed by the Governor under the said Act the Auditor-General of the Colony of New Zealand if he shall be satisfied that a sum of money is due on account of any debt or claim reported may certify to the Colonial Treasurer what amount is due on account of the debt or claim reported and upon such certificate being made to the Colonial Treasurer by the said Auditor-General such claim shall for the amount set forth in such certificate be a claim against the Colony of New Zealand under the provisions of the said Act and be satisfied as thereinafter provided: And whereas it is expedient to repeal the said "Appropriation Ordinance No. 1 1863" the said "Appropriation Ordinance No. 2 1863" and the said "Appropriation Ordinance No. 1

1864" and also to sanction and confirm the engagements and liabilities made and incurred by the Superintendent of the said Province for the public service thereof:

BE IT THEREFORE ENACTED by the Superintendent of the Province of Southland with the advice and consent of the Provincial Council thereof as follows:

- 1. The Short Title of this Ordinance shall be the "Provincial Short Title Liabilities Confirmation Ordinance 1865."
- 2. The said recited "Appropriation Ordinance No. 1 1863" Repeal of certain Ap-"Appropriation Ordinance No. 2 1863" and "Appropriation Ordinance propriation Ordinance nances." No.  $\bar{1}$  1864" are hereby repealed.
- 3. Every promise contract or engagement heretofore made or Engagements entered into by the said Superintendent with any person or persons for the payment of any sum or sums of money on account of the public service of the said Province not exceeding in respect of the several services following the respective amounts following that is to say

Every principal sum so agreed to be paid shall until the first Principal sums to day of January 1866 bear interest at the rate of eight per centum per annum to be computed from the date when such principal sum shall have become due and from and after such first day of January 1866 and until the same shall become a charge upon the ordinary revenue of the Colony under the provisions of the said Southland Provincial Debt Act 1865 shall bear interest at the rate of six per centum per annum.
