WHEREAS it is expedient to make provision for defraying the Preamble. charge of the Provincial Government of the Province of Taranaki for the period of twelve calendar months commenced on the first day of January 1859 BE it therefore enacted by the Superintendent of the Province of Taranaki with the advice and consent of the Provincial Council thereof as follows :---
