Title.

*An Ordinance to appropriate Money for the Public Service for the
Province of Taranaki for the year ending 31st December, 1860.*

Preamble.

WHEREAS it is expedient to make provision for defraying the charge of the Provincial Government of the Province of Taranaki for the period of twelve calendar months commenced on the first day of January one thousand eight hundred and sixty BE it therefore enacted by the Superintendent of the Province of Taranaki with the advice and consent of the Provincial Council thereof:—

1. For defraying the charge of the Provincial Government for the period of twelve calendar months commenced on the first day of January 1860 and ending on the thirty-first day of December in the same year there may be issued and applied out of the revenue of the said Province for the special purposes

and services specified in the Schedule to this Ordinance the sum of Three Thousand Eight Hundred and Eighty Pounds Six Shillings and Nine Pence.

2. And whereas the hereinafter mentioned sums amounting to Seven Hundred and Eighty-two Pounds and Fourteen Shillings were for the year 1859 under the warrant of the Superintendent issued and applied to the purposes hereinafter mentioned in excess of any sums appropriated for such purposes and whereas the said several expenditures were necessary to the public service BE it further enacted that the said several expenditures shall be deemed and taken to have been made under the authority of this Ordinance and the Provincial Treasurer shall take credit for the said sums accordingly that is to say—

3. If the next session of the Provincial Council shall not be held before the thirty-first day of March 1861 there shall and may be issued and applied out of the revenue of the Province any sum or sums of money not exceeding in the whole one-fourth part of the amount hereinbefore appropriated to defray from the first day of January to the thirty-first day of March 1861 the like salaries charges and expenses as are hereinbefore mentioned.

Provision for three months ending 31st March, 1861.

4. This Ordinance may be cited for all purposes as the "Appropriation Ordinance, 1860."
