*An Ordinance to appropriate Money for the Public Service for the Province of Taranaki for the Year ending 31st December, 1865.* Title.

WHEREAS it is expedient to make provision for defraying the charge of the Provincial Government of the Province of Taranaki for the period of twelve months ending 31st December 1865 BE it therefore enacted by the Superintendent of the Province of Taranaki with the advice and consent of the Provincial Council thereof as follows :— Preamble.

1. For defraying the charge of the Provincial Government of the said Province for the period of twelve months commenced on the 1st day of January 1865 and ending on the 31st day of December in the same year there may be issued and applied out of the Revenue of the said Province for the several purposes and services specified in the Schedule hereto the sum of £20,904 8s. 11d. Grant for services specified in Schedule.

2. And whereas the hereinafter mentioned sums amounting to £96 18s. 3d. were for the year 1864 under the warrant of the Superintendent issued and applied to the Provision for certain charges for the year 1864.

purposes hereinafter mentioned in excess of any sums appropriated for such purposes And whereas the said several expenditures were necessary to the public service Be it further enacted that the said several expenditures shall be deemed and taken to have been made under the authority of this Ordinance and the Provincial Treasurer shall take credit for the said sums accordingly that is to say—
