AN ORDINANCE TO APPROPRIATE MONEY FOR THE PUBLIC SERVICE OF THE PROVINCE OF TARANAKI FOR THE YEAR ENDING 30TH JUNE 1868.

Whereas it is expedient to make provision for defraying the Preamble. charge of the Provincial Government of the Province of Taranaki for the period of twelve calendar months commencing on the 1st day of July 1867. Be it therefore enacted by the Superintendent of the Province of Taranaki with the advice and consent of the Provincial Council thereof as follows:—

1. For defraying the charge of the Provincial Government for Grant for the period of twelve calendar months commencing on the 1st day in Schedule. of July 1867 there may be issued and applied out of the revenue of the said Province for the special purposes and services specified in the Schedule to this Ordinance the sum of Ten Thousand Three Hundred and Ninety Pounds.
