AN ORDINANCE TO DIVERT THE COURSE OF THE HUATOKI  
RIVER.

A N A L Y S I S :

Preamble  
1 Short Title

2. The Superintendent may divert  
Huatoke River and convey land  
reclaimed.

*AN ORDINANCE to Divert the Course of the Huatoki River.*

WHEREAS it is desirable that a portion of the Huatoki River Preamble.  
be diverted and a portion of the bed reclaimed by building a  
retaining wall and the land so reclaimed disposed of on such  
terms and conditions as the Superintendent shall think fit to  
David Callaghan. BE it therefore enacted by the Superin-  
tendent with the advice and consent of the Provincial Council  
thereof as follows :—

1. The short title of this Ordinance shall be the "Huatoke short Title.  
River Diversion Ordinance 1875, No. 2."

HUATOKI RIVER DIVERSION ORDINANCE.

The Superintendent may divert Huatoki River and convey land reclaimed.

2. It shall be lawful for the Superintendent to divert the Huatoki River and by building a retaining wall to reclaim a portion of the bed of the said river and to dispose of the land so reclaimed and described in the Schedule hereto to David Callaghan on such conditions as may be made in the deed conveying the same. Provided that the said David Callaghan does not hereby obtain any right of frontage on the outer boundary of the land so reclaimed from the said river but shall maintain in good repair for ever the retaining wall built to divert the said river from its original course.

SCHEDULE.

All that piece or parcel of Land in the Town of New Plymouth, containing by admeasurement six and one-third perches, bounded towards the north by Devon-street 17 links; towards the east by Allotments Nos. 905 and 906 169 links; towards the south by a line in prolongation of the southern boundary of Allotment No. 906 20 links; towards the west by a curved line to a point 27 links; in prolongation of the southern boundary of Allotment No. 905, and a straight line from the said point to one on the south side of Devon-street, 17 links west of the N.W. corner of Allotment No. 905.
