AN ORDINANCE TO ALTER THE SPECIFIC PURPOSE FOR WHICH CERTAIN PUBLIC RESERVES ARE HELD IN THE TOWN OF NEW PLYMOUTH AND TO AUTHORISE THE SUPERINTENDENT TO BORROW MONEY ON THE SAME,

An Ordinance to alter the specific purpose for which certain Public Title, Reserves are held in the Town of New Plymouth and to authorise the Superintendent to borrow money on the same,

Whereas by Deed of Grant bearing date the 20th day of Preamble, August 1858 the roads streets and squares in the Town of New Plymouth are vested in the Superintendent under the provisions of an Act of the General Assembly of New Zealand intituled "The Public Reserves Act 1854" upon the trust in the said deed mentioned And whereas by Deed of Grant bearing date the 27th day of February 1860 part of the Mount Eliot Reserve in the said Town was vested in the Superintendent under the provisions of the same Act upon the trust in the said deed declared And whereas it is expedient to change the specific purpose for which the last mentioned Reserve is held and to add thereto a portion of Brougham street in the said Town of New Plymouth Be it therefore enacted by the

Superintendent of the Province of Taranaki with the advice and consent of the Provincial Council thereof as follows :-

- Trusts of land
- 1. The land described in the first Schedule hereto comprised described in Schedule No. 1. In the said recited Deed of Grant dated the 20th day of August 1858 shall henceforth be held by the Superintendent as an endowment for a Harbour at the Sugar Loaves.
- Trusts of land lescribed in
- 2. The lands respectively described in the second Schedule schedule No. 2, hereto comprised in the said recited Deed of Grant dated the 27th day of February 1860 shall also be held henceforth by the Superintendent as an endowment for a Harbour at the Sugar Loaves.
- Superintendent empowered to sell or raise Schodules.
- 3. It shall be lawful for the Superintendent with the advice and consent of the Provincial Council expressed by a resolution noney on security of all or to that effect to sell all or any of the lands described in the said my of the lands Schedules or to raise such sum or sums of money by way of mortgage of the same or such portions thereof as he may deem expedient and to expend the monies to arise from the said lands in promoting the purposes for which the said lands are held by him under the authority hereof Provided that no such land shall be sold for a less price than Twenty Pounds per foot frontage.

4. The Short Title of this Ordinance shall be the "Harbour Trust Ordinance 1866"

SCHEDULE NO. 1.

All that piece or parcel of land containing twelve perches more or less being part of Brougham street in the Town of New Plymouth bounded towards the east by a straight line running parallel with the east side of the said street and commencing at a point on the west side of the said street four hundred and two links north of a projected street being a continuation of Gill street across the Huatoki river and Brougham street intersecting the reserve comprised in the said Deed of Grant of the twenty-seventh day of February one thousand eight hundred and sixtysix thence towards the north by a line at right angles to the last mentioned line ninety-five links and thence towards the west in an uniform curve to the point in Brougham street first named by Mount Eliot Reserve thirty links and by the reserve comprised in the said recited Deed of Grant two hundred and sixty links.

All that piece or parcel of land containing one rood nineteen perches more or less being part of the reserve comprised in the said Deed of Grant of the twentieth day of August one thousand eight hundred and fifty-eight bounded towards the north by Mount Eliot Reserve one hundred links towards the east by Brougham street four hundred and

two links towards the south by a projected street intersecting the reserve one hundred links and towards the west by Mount Eliot Reserve three

hundred and forty-two links.

All that piece or parcel of land containing fourteen and a half perches more or less being other part of the same reserve bounded towards the north by the projected street intersecting the reserve one hundred links towards the east by Brougham street ninety-one links towards the south by the remainder of the reserve one hundred links and towards the west by Mount Eliot Reserve ninety-one links.
