An Ordinance to alter the specific purpose for which a public reserve is held in the Town of New Plymouth.

WHEREAS by Deed of Grant bearing date the 20th day of August 1858 the roads streets and squares within the Town of New Plymouth are vested in the Superintendent of the Province of Taranaki under the provisions of an Act of the General Assembly of New Zealand intituled "The Public Reserves Act 1854" upon trust for public thoroughfares And whereas it is deemed expedient to change the specific purpose for which the public square described in the said Grant as St. Germain's Square is held BE it therefore enacted by the Superintendent of the Province of Taranaki with the advice and consent of the Provincial Council thereof as follows:—

1. The short title of this Ordinance shall be "The Taranaki Short Title. Agricultural Society's Trust Ordinance 1875."

2. The lands described in the Schedule hereto and comprised in the said recited Deed of Grant dated the 20th day of August 1858 shall henceforth be held by the Superintendent of the Province of Taranaki upon trust for the use and benefit of the Taranaki Agricultural Society.

Part of St. Germain's Square containing by admeasurement 1 acre 2 roods 30 perches bounded on the north by Molesworth-street 413 links on the east by a street 410 links on the south by Gill-street 413 links and on the west by Elliot-street 410 links.
