*An Ordinance to vest the Revenue arising out of a portion of the Title Educational Reserves in the Town Board of New Plymouth.*

WHEREAS by Deed of Grant bearing date the twentieth day of Preamble. August 1858 the unalienated lands within the Town of New Plymouth FitzRoy District are vested in the Superintendent of the Province of Taranaki under the provisions of "The Public Reserves Act 1854" upon trust as an endowment for Public Schools and for general Educational purposes And whereas it is deemed expedient that the revenue derived from a portion of the said lands should be vested in the Town Board of New Plymouth BE it therefore enacted by the Superintendent of the Province of Taranaki with the advice and consent of the Provincial Council thereof as follows :—

Lands described in Schedule to be held in trust for the Town Board of New Plymouth.

1. The lands described in the Schedule hereto and comprised in the said recited Deed of Grant shall henceforth be held by the Superintendent of the Province of Taranaki upon trust as an endowment to the Town Board of New Plymouth for the purpose of improving the streets of the said town.

Power to Superintendent to let lands.

2. It shall be lawful for the Superintendent to let the said land for any term not exceeding twenty-one years on such conditions as may be agreed upon as to rent and improvements and as to the right of the public to use the said land at stated periods for cricketing and horse racing.

Appropriation of rents.

3. All rents arising from the said lands shall be from time to time paid and accounted for to the Treasurer of the said Town Board and shall be appropriated to the purposes aforesaid subject to the provisions of this Ordinance and of any other Ordinance of the Superintendent and Provincial Council duly passed in that behalf.

Power to Town Board to raise money on mortgage of rents.

4. It shall be lawful for the said Town Board to raise money by way of mortgage on the rents derived from the said lands for the purpose herein named.

Short Title.

5. The Short Title of this Ordinance shall be the "Town Board of New Plymouth Endowment Ordinance 1867."

All those allotments or parcels of land containing 21 acres 1 rood more or less, being allotments numbered 1214, 1215, 1228, 1229, 1230, 1243, 1246, 1248, 1249, 1250, 1262, 1263, 1269, 1270, 1271, 1273, 1274, 1275, 1276, 1277, 1279, 1280, 1281, 1282, 1283, 1285, 1286, 1287, 1291, 1801, 1804, 1805, 1806, 1807, 1810, 1811, 1813, 1818, 1819, 1820, 1822, 1832, 1844, 1849, 1850, 1866, 1875, 1876, 1884, 1885, 1886, 1887, 1888, 1889, 1891, 1892, 1893, 1894, 1902, 1910, 1911, 1912, 1913, 1917, 1918, 1919, 1920, 1921, 1925, 1926, 1929, 1930, 1931, 1932, 1933, 1934, 1935, 1936, 1937, 1938, 1939, 1941, 1944, 1945, of the Town of New Plymouth in the Province of Taranaki.

2. Part of those allotments or parcels of land containing 1 rood 22 perches, more or less, being the southern portion of allotments numbered 1802, 1803, bounded on the north by the extensions of the northern boundary line of allotment No. 1801 to allotment No. 1804, of the Town of New Plymouth aforesaid.

3. All that allotment or parcel of land containing 1 acre 2 roods 7 perches, more or less, being allotment marked M of the Town of New Plymouth aforesaid.
