AN ORDINANCE to limit the application of an Ordinance to prohibit the use of shingles and other inflammable materials for roofing buildings within certain districts.

WHEREAS an Ordinance was enacted by the Superintendent and Provincial Council of Taranaki intituled "The Town Buildings Roofing Ordinance 1867" whereby provision was made for limiting the use of shingles and other inflammable materials for roofing buildings within certain districts and whereas it is expedient to suspend the operation of the said Ordinance except in the case of new buildings. Be it therefore enacted by the Superintendent of the Province of Taranaki with the advice and consent of the Provincial Council thereof as follows :—

Clause 2 of "Town Buildings Roofing Ordinance 1867" repealed.  
Period for which provisions of "Town Buildings Roofing Ordinance 1867" suspended.  
Power to Superintendent to suspend operation of clause of "Town Buildings Roofing Ordinance 1867."

1. Clause 2 of the "Town Buildings Roofing Ordinance 1867" shall be and the same is hereby repealed.

2. That the provisions of the "Town Buildings Roofing Ordinance 1867" shall be and the same is hereby suspended for the term of one year so far as the same relates to buildings already in existence.

3. It shall be lawful for the Superintendent with the advice and consent of the Provincial Council expressed by resolution from time to time to suspend the operation of the above recited Clause 2 of the "Town Buildings Roofing Ordinance 1867" for any period not exceeding the term of one year and so on from year to year.

Short Title. 4. The short title of this Ordinance shall be the "Town Buildings Roofing Ordinance Amendment Ordinance 1871."
