WHEREAS owing to the interruption of general business during the Maori insurrection in the Province of Taranaki certain transactions begun under the "Town of New Plymouth Consolidation Ordinance 1859" have not been completed and whereas the said Ordinance has expired and whereas it is expedient to complete the said transactions and to extend the time for the consolidation of the Public Reserves within the former boundary of the Town of New Plymouth BE it enacted by the Superintendent of Taranaki with the advice and consent of the Provincial Council thereof :-

Sections 2, 3, 4, 1. The second, third, fourth, and fifth sections of the said 5, of Town Con-Town of New Plymouth Consolidation Ordinance 1859 are nance reenacted. hereby re-enacted.

Transactions begun under former Ordinance may be completed.

2. All transactions begun under the "Town of New Plymouth Consolidation Ordinance 1859" which have lapsed owing to the expiration of the said Ordinance shall have the same validity as

if the said Ordinance had not expired but were now in force and the transactions so begun may be continued and completed as if they had been begun under the present Ordinance.

- 4. The Short Title of this Ordinance shall be the "Town of Short Title. New Plymouth Consolidation Ordinance 1860."
