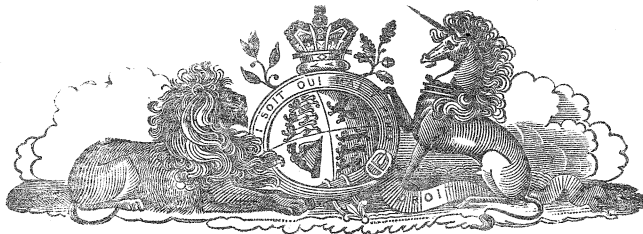

AN ACT to Establish Marine Boards for Ports in the Province. Title.

WHEREAS by the "Marine Board Act" 1862 of the General Preamble. Assembly it is enacted.

"THAT it shall be lawful for the Superintendent and Provincial Council of any Province by Act or Ordinance to be passed in that behalf before the thirty-first day of December in the year 1863 to constitute for any Port within such Province a Marine Board and to distinguish each Board by such name as may seem fit and to confer upon such Board any powers duties and functions subject to the provisions of this Act and to give power to the Superintendent of the Province to define the limits of jurisdiction of any such Board within the Province PROVIDED that every such Act or Ordinance shall be reserved for the Governor's assent."

BE IT THEREFORE ENACTED by the Superintendent with the advice and consent of the Provincial Council as follows:—

Boards to be established at certain Ports.

1. Marine Boards shall be established for the Ports of Wellington Wanganui Porirua Manawatu and Castle Point respectively.

Boards how to be styled.

2. The Marine Board established at the Port of Wellington shall be styled "The Wellington Marine Board" The Marine Board for the Port of Wanganui shall be styled "The Wanganui Marine Board" The Marine Board at the Port of Porirua shall be styled "The Porirua Marine Board" The Marine Board for the Port of Manawatu shall be styled "The Manawatu Marine Board" And the Marine Board for Castle Point shall be styled "The Castle Point Marine Board."

Number of Members.

3. Each of such Boards shall consist of Three Members.

Power to Superintendent to define limits.

4. The Superintendent shall define the limits of jurisdiction of such Boards respectively.

Power of Boards.

5. Such Boards shall have and may exercise the same powers duties and functions as are by Clause XL of the said "Marine Boards Act 1862" of the General Assembly declared to be the general powers and duties of Local Boards Provided however that the "Wellington Marine Board" shall not interfere with the powers over and affecting the Public Wharf in the Port of Wellington vested in the Superintendent and his Executive Council by the Act of the Provincial Council Session 8 No. 1.
