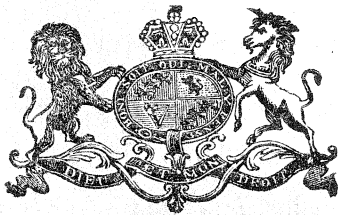

ANALYSIS

Title.

Preamble.

1. *Limitation of the time within which*

*Cattle may be slaughtered in the Town
of Wellington, elsewhere than in the
neighbourhood of Boorhampoor.*

*AN ACT to extend the period after which the Slaughtering of Cattle within
certain limits of the Town of Wellington is prohibited.* *Title.*

[Assented to February 6th, 1856.]

WHEREAS by an Act of the Provincial Council, Session II, No. 16, *Preamble.*

IT IS ENACTED, that after the first day of July, in the year of our Lord, One thousand eight hundred and fifty-six, any person slaughtering any Cattle, Sheep, or Pigs, within the Town of Wellington, except at or in the Slaughter House or Slaughter Houses intended to be erected and licensed at Boorhampoor Farm, in the said town, shall on conviction, be liable to a penalty of not less than One Pound nor more than Five Pounds, for every animal so slaughtered, to be summarily recovered: and any licence granted by the Justices of the Peace of the Province, authorizing such slaughtering elsewhere in the said town than at Boorhampoor aforesaid, after the day aforesaid, shall be void.

AND WHEREAS, It is desirable to extend the period after which the Slaughter of Cattle shall be prohibited other than as aforesaid.

1. BE IT THEREFORE ENACTED by the Superintendent of the Province, with the advice and consent of the Provincial Council thereof, that the before recited Act be repealed, and that after the Seventh day of July, in the year of our Lord, One thousand eight hundred and fifty-seven, any person slaughtering any Cattle, Sheep, or Pigs, within the Town of Wellington, excepting at any Slaughter Houses that may be erected in the neighbourhood of Boorhampoor Farm, in the said Town, shall on conviction, be liable to a penalty of not less than One Pound nor more than Five Pounds, for every animal so slaughtered, to be summarily recovered: and any license granted by the Justices of the Peace of the Province, authorising such slaughtering within the Town elsewhere than in the neighbourhood of Boorhampoor aforesaid, after the day aforesaid, shall be void.
