A ORDINANCE TO EMPOWER THE SUPERINTENDENT OF THE PROVINCE <sup>Title:</sup>  
OF WESTLAND TO STOP UP FITZGERALD-STREET AND PORTIONS  
OF CERTAIN STREETS AND THOROUGHFARES IN THE TOWN OF  
HOKITIKA.

### ANALYSIS.

Preamble.  
1. Short Title.

2. Superintendent may close streets.  
3. Superintendent may dispose of land.

**W**HEREAS by an Act of the General Assembly of New Zealand <sup>Preamble.</sup>  
intituled "The Highways and Water Courses Diversion Act,  
1858," it is enacted that it shall be lawful for the Superintendent of  
any Province, with the advice and consent of the Provincial Council  
thereof, by any Law or Ordinance to be made or ordained for that  
purpose, to authorise and empower the Superintendent to divert or stop  
up any public street, road, highway, or thoroughfare in any such  
Province, and also to sell, exchange, or otherwise dispose of the land  
over which any such public street, road, highway or thoroughfare  
was laid out or passed.

And whereas it is expedient to stop up FitzGerald-street and the  
portions of the other streets, lanes, roads, or thoroughfares, hereinafter  
mentioned in the Town of Hokitika in the Province of Westland.

BE IT therefore enacted and ordained by the Superintendent of the  
said Province, with the advice and consent of the Provincial Council  
thereof, as follows :—

Short Title.

1. The Short Title of this Ordinance shall be "The Hokitika Street Closing Ordinance, 1874."

Superintendent  
may close streets

2. It shall be lawful for the Superintendent, by proclamation to be published in the *Gazette* of the said Province to close and stop up the street and portions of streets, lanes, roads, or thoroughfares, mentioned and described in the Schedules to this Ordinance or any or either of the same respectively.

Superintendent  
may dispose of  
land.

3. It shall be lawful for the Superintendent with the advice and consent of the Waste Lands Board of the said Province, expressed or given by any resolution of the said Board, to sell, exchange, or otherwise dispose of the land or any part thereof, over which any such street, or portion of street, or streets, lanes, roads, or thoroughfares, which shall or may be so stopped up or closed as aforesaid was laid out or passed.

#### SCHEDULE.

1. All that street in the Town of Hokitika known as FitzGerald-street, commencing in Bealey-street in the said town, and running in a north-westerly direction to Fitzherbert-street, and thence running northerly in a diagonal direction to Tancred-street.

2. All those portions of the eastern town belt of Hokitika aforesaid, and all those portions of Tudor-street, Park-street, and Dalton-street, in the said town, which run through or are comprised or contained in the block of land described as follows (that is to say)—all that block of land containing twenty-six acres, or thereabouts:—Bounded towards the south-east by a line along the south-eastern boundary of the town belt, commencing at a point on that boundary which is distant 100 links in a north-easterly direction from the point where it is intersected by the north-eastern boundary of Tudor-street, and running south-westerly for a distance of 20 chains; thence by a line running in a north-westerly direction at right angles with the last-mentioned line, and parallel with Hampden-street for a distance of thirteen chains; thence by a line running in a north-easterly direction at right angles with the last-mentioned line, and parallel with Livingstone-street for a distance of 20 chains; and thence by a line running in a south-easterly direction at right angles with the last-mentioned line, and parallel with Spencer-street for a distance of 13 chains to the point of commencement.

3. All that portion of the lane or thoroughfare situate between Revell and Tancred-streets, and leading into Hamilton-street, in the Town of Hokitika, which lies to the south-east of a straight line drawn as a continuation of the north-western boundary of Section No. 3179 extended to Hamilton-street aforesaid.
