  SPECIAL CONDITIONS.
- In the Court of Arbitration of New Zealand, Wellington Industrial District.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and its amendments; and in the matter of the Wellington Industrial District Metal-workers' Assistants' award, dated the 3rd day of October, 1938, and recorded in Book of Awards, Vol. XXXVIII, p. 2913.

Thursday, the 23rd day of March, 1939.

Upon reading the application to add a party made by the Wellington Metal-workers' Assistants' Industrial Union of Workers party to the Wellington Industrial District Metalworkers' Assistants' award, dated the 3rd day of October, 1938, and recorded in Book of Awards, Vol. XXXVIII, p. 2913, which application was filed herein on the 21st day of March, 1939, and upon being satisfied that reasonable notice of the said

application has been given to the undermentioned company, with the consent of the said company this Court doth order as follows:—

1. That Metters (N.Z.), Ltd., Petone, be and it is hereby added as a party to the said award in respect of its porcelain-enamelling department, subject to the following special conditions:—

(i) The minimum rates of wages per hour shall be— Inside duster 4 3 2 101 Roll duster 9 Wheel man To these wages shall be added bonuses as Inside duster— For alpha baths ... For plain rolled baths Roll duster— For alpha baths ... For plain rolled baths Wheel man— For alpha baths ... 3 0 0

For plain rolled baths ... 0 2
These bonuses shall be paid on all first-quality baths produced on each shift so long as not less than 25 per cent. of first-quality baths are produced on each shift.

(ii) Shot-blasters, while so engaged, shall be paid not less

than 3s. 6d. per hour.

(iii) The standard output per shift shall be eighteen baths. For every bath in excess of eighteen per shift the inside duster shall be paid 2s. 1½d., the roll duster 1s. 5d., and the wheel-man 1s. 4d. per bath.

All the above-mentioned rates shall be inclusive of the shift allowance prescribed in clause 3 (a) of the said award and of all other extra payments whatsoever.

excepting overtime payments.

- (iv) Notwithstanding anything elsewhere contained in the said award, the present hours and method of working shifts may be continued; and the third shift on Fridays in the porcelain-enamelling department may be continued beyond midnight, if necessary, to complete the shift's work without payment of overtime so long as forty hours are not exceeded for the week.
- 2. That this order shall operate as from the day of the date hereof.
