- NORTHERN INDUSTRIAL DISTRICT (EXCEPT AUCKLAND (TWENTY-ONE-MILE RADIUS) AND GISBORNE JUDICIAL DISTRICT) BUTCHERS.—AMENDMENT OF AWARD
- In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations 1942; and in the matter of the Northern Industrial District (except Auckland (twenty-one-mile Radius) and Gisborne Judicial District) Butchers' award, dated the 11th day of October, 1946, and recorded in 46 Book of Awards 1382.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Emergency Regulations 1942, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 15th day of August, 1947, doth hereby order as follows:—
