### REGISTERED COLLECTIVE AGREEMENT

In the matter of the Industrial Relations Act 1973; and in the matter of the Rotorua City Council Senior Officers' Dispute of Interest between the Auckland Provincial District Local Authorities Officers' Industrial Union of Workers and the Rotorua City Council.

The Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the schedule hereto, and orders:

1. That the said terms, conditions and provisions shall be binding on the

2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

# ROTORUA CITY COUNCIL SENIOR OFFICERS' COLLECTIVE AGREEMENT

This Agreement made in pursuance of the Industrial Relations Act 1973 this 1st July 1978 between the Rotorua City Council (hereinafter called "the Council" or the "employer") of the one part and the Auckland Provincial District Local Authorities Officers' Industrial Union of Workers (hereinafter called "the Union") of the other part whereby it is mutually agreed by and between the said parties as set out in the following Schedule:

### SCHEDULE

### SCOPE OF AGREEMENT

1. This Agreement shall apply only to the Town Clerk and City Engineer employed by the Rotorua City Council or its successor.

### TERMS AND CONDITIONS OF EMPLOYMENT

2. (a) Subject to the provisions of subclause (b) of this clause, except where existing terms and conditions of employment are more favourable the provisions of the "Rotorua City Council Officers' Collective Agreement" and /or any subsequent amendment to that Agreement shall be deemed to be applicable to Officers covered by this Collective Agreement;

(b) Provided however, that while the salaries of Officers covered by this Collective Agreement are subject to the provisions of the Higher Salaries Commission Act 1977, the salary provisions of the "Rotorua Gity Council Officers' Collective Agreement" shall not be applicable to Officers covered by this Col-

lective Agreement.

### COMMENCEMENT DATE AND TERM OF AGREEMENT

3. This Agreement shall be deemed to have come into effect on the 1st day of April 1978, and this Agreement shall remain in force until superseded by a new Agreement arranged by the parties, such date to be not before twelve months following the commencement of this Agreement.

#### **MEMORANDUM**

Although the Court has registered the agreement as submitted the parties are reminded that where any provision of the Rotorua City Council Officers Collective Agreement as applied to the Officers in question would have the effect

of increasing their remuneration beyond the remuneration determined by the Higher Salaries Commission pursuant to the Higher Salaries Commission Act 1977 then this provision shall have no effect.

Having regard to prevailing circumstances the Court has, pursuant to section 92(2) of the Industrial Relations Act 1973, consented to the specified period for which this collective agreement is to continue in force being less than one year from the date of registration.
