TERMS OF VOLUNTARY AGREEMENT

**UNDER SECTION 141 OF THE
INDUSTRIAL RELATIONS ACT 1973**

BETWEEN

THE JOINT COUNCIL FOR LOCAL AUTHORITIES SERVICES

AND

THE JOINT COUNCILS FOR LOCAL AUTHORITIES SERVICES

SALARIED EMPLOYEES SOCIETY (NOT INCORPORATED)

VOLUNTARY AGREEMENT**

This Agreement made in pursuance to Section 141 of the Industrial Relations Act 1973 this 20th day of March 1986 between the Joint Council for Local Authorities Services (hereinafter called the "Joint Council" or "the Employer") of the one part and the Joint Council for Local Authorities Services Salaried Employees Society (Not Incorporated) (hereinafter called "the Society") of the other part whereby it is mutually agreed by and between the said parties as set out in the following schedule.

SCHEDULE

1 APPLICATION OF AGREEMENT

This agreement shall only apply to the positions of Executive Officer (Personnel Services) and Executive Officer (Finance).

2 TERMS AND CONDITIONS OF EMPLOYMENT

The terms and conditions of employment, other than salaries, for the two Executive Officers shall be equal to the terms and conditions of employment contained in the Wellington City Council Technical, Professional, Clerical and Other Officers Award registered by the Arbitration Court on 12 March 1985 or such other awards which may be substituted therefore from time to time, excepting Clauses 1, 2, 3(g), 4(b)(i)(ii), (c), (d), 5(b)(i)(ii), 6, 9, 13, 14, 20, 21, 24 and 25.

3 SALARIES

The salaries applying as at 10 November 1985 are:

Executive Officer (Personnel Services)	\$41,041
Executive Officer (Finance)	\$36,900

4 STATE LINKAGE

The annual rates of remuneration provided for in this Agreement are related to the rates in the scale of annual salaries of the 007 Executive/Clerical occupational classes in the State Services. The aforesaid rates shall be amended from time to time both as to date of application and quantum of adjustment in accordance with salary determinations issued by the State Services Commission in accordance with the provisions of Section 30 or Section 31 of the State Services Conditions of Employment Act 1977.

5 TERMS OF AGREEMENT

This agreement shall be deemed to have come into force on the 10th day of November 1985 and shall continue in force until the 10th day of November 1987.
