## PROCLAMATION.

By His Excellency **ROBERT FITZROY**, Esquire, Captain in Her Majesty's Royal Navy, Governor and Commander-in-Chief in and over the Colony of New Zealand and its Dependencies, and Vice Admiral of the same, &c., &c., &c.

**W**HEREAS by an Ordinance enacted by the Governor of New Zealand, with the advice and consent of the Legislative Council, Session 2, No. 9, intituled "An Ordinance to provide for the Registration of Deeds and Instruments affecting Real Property," it is enacted, "that there shall be established in every County or District, as the case may be, within the Colony, an office which shall be called the 'Register Office,' for registering in manner hereinafter directed the Deeds, Wills, and Memorials thereby authorized to be registered." And Whereas it is thereby further enacted, "that the said Ordinance shall come into operation within any County or District at such time as His Excellency the Governor with the advice of the Executive Council, shall by Proclamation appoint."

Now, therefore, I, the Governor, in pursuance of the power and authority in me vested, by the said in part recited Ordinance, do hereby, with the advice of the Executive Council, appoint that the said Ordinance shall come into operation within the District of Port Nicholson, or

Wellington, on Wednesday, the first day of October, next ensuing.
