And whereas the configuration of the Borough of Napier is such that within the area described in the Schedule hereto it is inexpedient to construct streets of a width of sixty-six

Now, therefore, in pursuance and exercise of the powers vested in him by the Municipal Corporations Act, 1908, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby authorize the Napier Borough Council to permit, within the area described in the Schedule hereto, the laying-off of a street within the said area of a width less than sixty-six feet but not less than forty feet. forty feet.
