1. Alick Merriott Pickford, of Swanson Street, Auckland, to be the Returning Officer for the purpose of taking the said poll, and also to be the person authorized to prepare a voters roll of the persons entitled to vote at the said poll.

N pursuance and exercise of the powers and authorities rested in him by the Animals Protection Act, 1908. as amended by the Animals Protection Amendment Act, 1910, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby or the executive Council of the said Dominion, doth hereby suspend the operation of section ten of the said Animals Protection Amendment Act, 1910, for the period commencing on the first day of May, one thousand nine hundred and thirteen, and ending on the thirty-first day of July, one thousand nine hundred and thirteen, with respect to the species of birds indigenous to New Zealand mentioned in the Schedule hereto:

Provided, however, that the said birds shall not be taken or killed except in such districts and on such conditions as may be notified by the Governor under the said Acts.
