exclude from the said borough parts only of the areas mentioned in the said petition and notice:

Now, therefore, in pursuance and exercise of the powers and authorities vested in him by the Municipal Corporations Act, 1908, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that as on and from the first day of April, one thousand nine hundred and fourteen, the area described in the First Schedule hereto shall be excluded from the Borough of Waitara and included in the Waitara West Riding of the County of Taranaki, and that the area described in the Second Schedule hereto shall be excluded from the said the Second Schedule hereto shall be excluded from the said Borough of Waitara and included in the Waihi Riding of the County of Clifton, and that the area described in the Third Schedule hereto shall be excluded from the said Borough of Waitara and included in the Tikorangi Riding of the County of Clifton.
