A PROCLAMATION.

WHEREAS the land described in the Schedule hereto is required to be taken, under the Public Works Act, 1908, for a certain public work, to wit, for the purposes of a post-office in Block XI, Tiffin Survey District:

And whereas an agreement has been entered into, in terms of section twenty-seven of the said Act, to take such land for the public work hereinafter set forth:
