Letters and other articles originating outside New Zealand which bear a special request for return to the sender if not delivered within a stated period are sent by Chief Postmasters at the end of such period to the Dead Letter Office, Wellington, for immediate return to the country of origin. Printed matter posted outside the Dominion, which bears thereon a special request for return to an address in New Zealand if not delivered, or in respect of which the sender makes such an application, will be so returned, but if prepaid $\frac{1}{2}d$. only it will be charged $\frac{1}{2}d$. postage.
