## A PROCLAMATION.

WHEREAS by the Public Works Amendment Act, 1909, it is enacted that if at any time after the issue or making of any Proclamation taking land under the Public Works Act, 1908, and before the payment or award of any compensation in respect of the taking thereof, it is found that the land, or any part thereof, is not required for the purpose for which it was taken, or that any error in form or substance exists in or in relation to that Proclamation or the making or gazetting thereof, the Governor may, by a subsequent Proclamation gazetted, revoke the former Proclamation either wholly or so far as he thinks necessary: And whereas it is found that the hereinafter-mentioned part of certain land in Block X, Christchurch Survey District, taken with other land for the development of the Lake Coleridge water-power scheme by a Proclamation made under the Public Works Act, 1908, dated the twentieth day of June, one thousand nine hundred and thirteen (hereinafter termed "the said Proclamation"), and published in the *New Zealand Gazette* No. 49, of the twenty-sixth day of the same month, is incorrectly described: And whereas compensation in respect of the taking of the said land has not been paid or awarded:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers vested in me by the Public Works Amendment Act, 1909, and of all other powers enabling me in this behalf, do hereby revoke so much of the said Proclamation as affects three rods twenty-nine perches, being part of Section 145, Block X, Christchurch Survey District (shown coloured yellow on the plan marked P.W.D. 33596, deposited in the office of the Minister of Public Works, at Wellington), being the whole of the land lastly mentioned in the Schedule to the said Proclamation.

## A PROCLAMATION.

WHEREAS the land described in the Schedule hereto is required to be taken, under the Public Works Act, 1908, the Scenery Preservation Act, 1908, and the Scenery Preservation Amendment Act, 1910, for scenic purposes in Kawhia North Survey District:

And whereas all the conditions precedent required by law to be observed and performed prior to the taking of such land for the purposes hereinbefore specified have been observed and performed:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, the Scenery Preservation Act, 1908, and the Scenery Preservation Amendment Act, 1910, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for scenic purposes; and I do also hereby declare that this Proclamation shall take effect on and after the sixth day of September, one thousand nine hundred and thirteen.
